



**SolarEdge Technologies  
Build America, Buy America Act Certification**

As required by the Build America, Buy America Act, enacted as part of the Bipartisan Infrastructure Law (also known as the Infrastructure Investment and Jobs Act), P.L. 117-58, on or after May 14, 2022, none of the funds under a federal award that are part of Federal financial assistance program for infrastructure may be obligated for a project unless all of the manufactured products used in the project are produced in the United States, unless subject to an approved waiver.

This means the manufactured product was manufactured in the United States, and the cost of the components of the manufactured product that are mined, produced, or manufactured in the United States is greater than 55 percent (currently) of the total cost of all components of the manufactured product, unless another standard for determining the minimum amount of domestic content of the manufactured product has been established under applicable law or regulation.

The required domestic content threshold has increased, and will increase, as follows:

March 7 – October 24, 2022	55%
October 25, 2022–December 31, 2023	60%
January 1, 2024 – December 31, 2028	65%
January 1, 2029	75%

**For the Three Phase Inverter 10kW or 17.3kW @208VAC, 30kW or 40kW @480V the BABA requirement of 65% is met when coupled with any number of optimizers.**

**For each 80kWac Synergy system, the BABA requirement of 65% is met when coupled with a minimum of 150 units of C651U / C652U power optimizers.**

**For each 50kW@208VAC, 100kW, 110kW and 120kW@480VAC Synergy system, the BABA requirement of 65% is met when coupled with a minimum of 85 units of C651U / C652U power optimizers.**
