

SolarEdge RE-POWER 400 and RE-POWER 1000 Campaign Terms and Conditions for Installers

PLEASE READ THESE TERMS AND CONDITIONS CAREFULLY BY PARTICIPATING IN THE SOLAREEDGE RE-POWER 400 or 1000 CAMPAIGNS (THE “PROMOTION”), YOU AGREE TO BE BOUND BY THE TERMS AND CONDITIONS BELOW. THESE TERMS AND CONDITIONS ARE SUBJECT TO CHANGE WITHOUT NOTICE, FROM TIME TO TIME IN OUR SOLE DISCRETION. IF YOU DO NOT AGREE WITH THESE TERMS AND CONDITIONS, PLEASE DO NOT ENROLL IN THE PROMOTION.

1. General description

The Promotion allows you to increase sales by facilitating your customers, existing residential SolarEdge system owners, to receive a gift card or gift cards with maximum value of €400 (including VAT) for RE-POWER 400 or €1000 for RE-POWER 1000 as applicable (the “Gift Card”)

RE-POWER 400: for adding one SolarEdge Home Battery 400V to an existing site with a 1-phase SolarEdge Home Hub Inverter or Wave inverter or adding at least two SolarEdge Home Battery 48V units to an existing site with a 3-phase SolarEdge Home Hub or Wave inverter (“Qualified Battery”). To qualify your customer for the gift card, the battery must be added to the monitoring portal and be online before September 30th, 2024 (“Promotion Expiry Date”).

RE-POWER 1000: for purchasing a new SolarEdge HomeHub 3PH Inverter to replace an existing installed SolarEdge HomeWave 3PH Inverter up to SE17K (SExK-RWO) (the “Existing Inverter”) and adding two SolarEdge Home Battery 48V at the same site. The Existing Inverter must be disconnected, and the new inverter and batteries must be installed and added to the SolarEdge monitoring platform and be online between April 8th and September 30th, 2024 (“Promotion Expiry Date”).

2. Promotion Process

SolarEdge will issue invitation emails and pop-up messages through the monitoring platform to customers associated with you inviting them to register for the Promotion. SolarEdge will send you a copy of the customer registration request once submitted (“Registration Request”). You will engage with the customer to complete the installation of the Qualified Battery by the Promotion Expiry Date for RE-POWER 400 and for RE-POWER 1000 to complete the installation of the new Inverter and batteries, disconnection of the Existing inverter by the Promotion Expiry Date. for RE-POWER 400 upon installation completion, you will enter each customer’s details in the designated SolarEdge webpage confirming installation completion [site number, customer name, battery/batteries SN number, customer email and mobile number as provided by the customer in the registration application] and for RE-POWER 1000, upon installation completion you will enter each customer’s details in the designated SolarEdge webpage confirming installation completion [site number, customer name, battery/batteries SN number, New and Existing Inverter SN numbers, customer email and mobile number as provided by the customer in the Registration Request] - (“Completion Report”). SolarEdge will verify compliance of the information submitted with the terms and conditions of this Promotion including installation and connection to the monitoring platform and disconnection of the Existing Inverter as applicable, by the Promotion Expiry Date and issue you and the customer confirmation of completion. Within 30 days of SolarEdge’s verification of the Completion Report, the Gift Card will be made available directly to the customer by VEMT via the email address provided. The customer needs to activate the Gift Card.

By accepting these terms and conditions you commit to promoting the SolarEdge Promotion materials in your digital channels and to following up on registration of your customers to the Promotion in a timely manner and no later than within 2 business days from the Registration Request. If you will not

contact the customer and process their Registration Request within 30 days of receipt of the request, SolarEdge may refer the Registration Request and customer to other installers for completing this Promotion. You agree to provide SolarEdge with bi-weekly updates on the status of registered customers and estimated time for completion of installation.

The Promotion is limited to a Gift Card with a value of €400 or €1000 as applicable per site (designated as a unique site ID) and one contact person. Placing multiple batteries at a single site does not entitle to multiple Gift Cards. Gift Cards not activated within 60 days of SolarEdge confirmation and Gift Card receipt will be revoked. Completion Reports must be issued by the Installer no later than within 60 days of the Promotion Expiry Date to be eligible for the Gift Card.

3. Eligibility

To be eligible to participate in the promotion, you must (a) be a resident of the Netherlands who is at least 18 years old, (b) be an authorized installer of SolarEdge (with the applicable certification to install SolarEdge Home Battery) who purchased the batteries from such authorized reseller of SolarEdge in the Netherlands and (c) comply with the terms of the Promotion and (d) the installation region is limited to the Netherlands only. Installers are required to provide accurate, current, and complete information and comply with all applicable laws.

4. Privacy and Personal Data

by participating in this Promotion, you accept these terms and condition and agree for SolarEdge to use your name and logo in personalized communications sent to customers in connection with this Promotion.

The processing of personal data is governed by SolarEdge's Privacy Policy, which can be found on SolarEdge's website (<https://www.solaredge.com/nl/privacy>).

5. Delivering the Existing Inverter.

For RE-POWER 1000: As part of the Promotion, you shall send the Existing Inverter to the SolarEdge warehouse in the Netherlands after submitting the necessary case number on the Gift Card claim form (<https://marketing.solaredge.com/nl/repower-giftcard>). You commit to disconnecting and returning the Existing Inverter to SolarEdge by the Promotion Expiry Date. SolarEdge will cover the shipping costs of returning the Existing Inverter. SolarEdge may revoke installer participation in the Promotion and/or revoke issued gift card in case of non-compliance and you commit to indemnifying SolarEdge for any damage caused including the value of a gift card issued.

Please note that as part of the Promotion, you acknowledge and declare that you are directly and solely responsible to ensure that: (i) the homeowner, from whom the Existing Inverter was removed, authorized to collect the Existing Inverter from the site and send it to the SolarEdge warehouse; and (ii) that upon delivery, the title of the Existing Inverter transfers from you to SolarEdge as part of the Promotion, free and clear of all liens, claims, or encumbrances.

Warranty: Each replacement inverter will come with a new, 12-year warranty, which shall be governed by SolarEdge's Limited Product Warranty which can be found on SolarEdge's website. If an extended warranty is desired, please follow the instructions at this link on how to purchase an extended warranty.

6. General

6.1 Duration and Scope. The term of the Promotion is April 8th - September 30th, 2024 (the "Term"). The RE -POWER 400 Promotion is limited to 200 Gift Cards and the RE-POWER 1000 Promotion is limited to 200 Gift Cards. Once SolarEdge has issued the limited number of Gift Cards under the Promotion, the Promotion shall automatically terminate. SolarEdge reserves the right to extend/cancel/change the RE-POWER 400 Promotion or the RE-POWER 1000 Promotion at its sole discretion without incurring any obligation to inform the participants. If, in SolarEdge's sole discretion, a participant or installer breaches any of these Terms and Conditions, acts unlawfully, tampers or attempts to tamper with the Promotion, SolarEdge reserves the right to disqualify an installer from participating in the Promotion, refer the registered customers to other installers, disqualify a Gift Card claim and in such an event any Gift Card will be forfeited. SolarEdge's decision shall be final and binding.

6.2 Gift Cards are not redeemable for cash or other goods and will only be issued to the named Participant. The Gift Cards are not transferable. The Gift Card recipient will be responsible for all expenses and/or taxes that may be associated with the acceptance of the Gift Card. SolarEdge may withhold taxes if required to do so by applicable law. Realizing the Gift Card is subject to third party providers' terms.

6.3 To the extent permitted by law, you will indemnify SolarEdge against all costs, damages, expenses and losses that SolarEdge may suffer or incur as a result of your actions or inactions arising out of or in connection with the Promotion. Without limiting the above under no circumstances is SolarEdge liable to any participant for any indirect or consequential losses, including but not limited to loss of opportunity or loss of profit. THIS CAMPAIGN IS VOID WHERE PROHIBITED BY LAW.

6.4 Limitation of liability - no warranties. EXCEPT AS SPECIFICALLY SET OUT HEREIN OR WHERE THE LAW REQUIRES A DIFFERENT STANDARD, SOLAREEDGE SHALL NOT BE RESPONSIBLE FOR ANY LOSS, DAMAGE, INJURY, OR FOR ANY DIRECT, INDIRECT, SPECIAL, INCIDENTAL, EXEMPLARY OR CONSEQUENTIAL DAMAGES, INCLUDING (WITHOUT LIMITATION) LOST PROFITS, LOSS OF BUSINESS, REVENUE, PROFITS, GOODWILL, USE OR OTHER ECONOMIC BENEFIT, HOWSOEVER ARISING, WHETHER THROUGH BREACH OF CONTRACT, BREACH OF WARRANTY OR TORT, INCLUDING NEGLIGENCE AND EVEN IF SOLAREEDGE HAS PREVIOUSLY BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
